Currently, we are functioning treatment and intermediate care centers in Central Province, with a bed capacity of around 2000. In order to meet the foreseen increased demand, we are planning to establish 3000 intermediate care center beds and 2000 secondary care center beds that will enable us to accommodate 5000 patients.
